The Amendment of Article 1

**Of the Sub-decree No. 08 ANKr.BK dated January 31, 2005
on Defining Investment Principles for All Kinds of Mineral Resources**

- Having seen the Royal Kram No. 03/NS/94 dated August 05, 1994 promulgated the Law on Investment of the Kingdom of Cambodia and the Royal Kram No. NS/RKM/0303/009 dated March 24, 2003 promulgated the Law on the Amendment of the Law on Investment of the Kingdom of Cambodia
- Having seen the Royal Kram No. NS/RKM/0701/09 dated July 13, 2001 promulgated the Law on Mineral Management and Exploitation
- Having seen the Sub-decree No. 70 ANKr.BK dated July 27, 2001 on the Organization and Functioning of the Cambodia Development Council and the Sub-decree on subsequent amendments No. 112 ANKr.BK dated November 12, 2002 and No. 35 ANKr.BK dated August 04, 2004
- Having seen the Sub-decree No. 88 ANKr.BK dated December 29, 1997 on the Implementation of the Law on Investment of the Kingdom of Cambodia and the Sub-decrees on subsequent amendments No. 53 ANKr.BK dated June 11, 1999 and No. 130 ANKr.BK dated June 26, 2001
- Pursuing to the needs of the Royal Government of Cambodia

DECIDES

Article 1

Article 1 of the Sub-decree No. 08 ANKr.BK dated January 31, 2005 on Defining Investment Principles for All Kinds of Mineral Resources has been changed as follows:

New Article 1

For all the requests to conduct mineral primary studies (prospecting) and exploitation with whatever scale shall abide by the Law on Mineral Management and Exploitation. For the requests to conduct mineral exploitation with the exception of luxury stones and construction materials (stone, gravel, sand, laterite, earth, etc.) shall pass through one-stop service of the Cambodia Development Council after having gone through primary studies (prospecting) and exploration with advices from MIME.

After having obtained agreement in principle from the Cambodia Development Council to the above exploitation requests, MIME shall issue Licenses for Industrial Mineral Exploitation in compliance with the Law on Mineral Management and Exploitation.

Article 2

Any provisions contradicting to this Sub-decree shall be abrogated.

Article 3

The Minister in charge of the Office of the Council of Ministers, Co-chairs of the Cambodia Development Council, Co-ministers of Interior, Minister of Economy and Finance, Minister of MIME, Minister of Commerce, Minister of Environment, Minister of Agriculture Forestry and Fisheries, Ministers, State Secretaries of all Ministries and Institutions, all concerned Provincial/municipal Governors, shall effectively implement this Sub-decree from the date of signature.
